**SMITH COUNTY EMERGENCY SERVICES DISTRICT NO. 2**

**A RESOLUTION LEVYING A TAX RATE FOR THE SMITH COUNTY EMERGENCY SERVICES DISTRICT NUMBER 2 OF SMITH COUNTY, TEXAS FOR THE TAX YEAR 2022**

WHEREAS, it was necessary to set and adopt a tax rate in order to allow the SMITH COUNTY EMERGENCY SERVICES DISTRICT NUMBER 2 (the "DISTRICT") to carry out its purposes, objectives, maintenance, and operations; and

WHEREAS, the Board of Commissioners gave notice of the date, time and place of the meeting at which it would vote on the tax rate for the DISTRICT accordance with the law and, after all requirements for consideration and adoption of a tax rate had been met, the Board of Commissioners did hold such a meeting to vote on the tax rate; and

WHEREAS, the Board of Commissioners of the DISTRICT did, on the 12th day of September 2022, then and there adopt the tax rate of \$0.060436 per \$100 valuation for maintenance and operations of the DISTRICT and the tax rate of \$0.00 per \$100 valuation for the payment of principal and interest on bonded debt of the DISTRICT, for a total tax rate of \$0.060436 per \$100 valuation on taxable property within the DISTRICT by a recorded vote of 5 votes in favor,    votes against,    absent, and    abstentions; and

WHEREAS, it was, and is, in the public interest and welfare to adopt such tax rate for the purpose of carrying out the purposes, objectives, maintenance, and operations of the DISTRICT.

**THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**

**NOW, THEREFORE, BE IT ORDAINED AND ORDERED by the Board of Commissioners of the SMITH COUNTY EMERGENCY SERVICES DISTRICT NUMBER 2, that,**

**We, the Board of Commissioners of the SMITH COUNTY EMERGENCY SERVICES DISTRICT NUMBER 2 of Smith County, Texas, do hereby levy or adopt the tax rate per \$100 valuation for the District for the tax year 2022 as follows:**

**\$0.060436 – total tax rate**

**\$0.060436 for the purpose of the maintenance and operations of the SMITH COUNTY EMERGENCY SERVICES DISTRICT NUMBER 2.**

**\$0.000000 for the payment of principal and interest on bonded debt of the SMITH COUNTY EMERGENCY SERVICES DISTRICT NUMBER 2.**

The Tax Assessor/Collector is hereby authorized to assess and collect the taxes for the Smith County Emergency Services District Number 2 of Smith County, Texas employing the above tax rate.


