# WIRFLESS TECHNICIAN

## **GENERAL PURPOSE**

Under the general supervision of the I.T. Manager, performs complex professional work with computer hardware and network systems. Installs and supports radios, microwave antennas, and network operations; provides hardware implementation; provides problem solving; and ensures systems efficiency and integrity.

#### **EXAMPLE OF DUTIES**

- Provides quality end-user support by chat, email, phone and in-person.
- Answer phones for I.T. department.
- Provides advanced hardware support for I.T. systems as delegated by supervisor.
- Resolves helpdesk tickets, resets users' passwords, escalates tickets if request is beyond scope.
- Identifies and corrects operational problems on technology systems.
- Assembles and installs hardware such as microwave antennas and radios, investigates and resolves routine hardware and communications problems.
- Repair of equipment such as Mobile Devices, Gas Detectors, Radios, etc. (Training provide for specialty equipment)
- Assists in network monitoring.
- Perform on location support for incident management operations during Incident Management Team deployments, Emergency Operation Center Activations and during Lean Forward situations.
- Assists with Network Management including implementation and wiring, overall network operation. As well as assisting with LAN/WAN System integrity and security.
- Assists with installation and configuration of network hardware.
- Runs monthly reports for the I.T. Manager.
- Reports the amount of wireless network downtime to the I.T. Manager.
- Assists the I.T. Manager in preparing the I.T. budget request by recommending purchases of hardware and software needed to operate the network, servers and desktop PCs.
- Primary for tower climbs to install and maintain radio and microwave equipment.
- Performs other related duties as required or assigned by the I.T. Manager.

#### **RESPONSIBLE FOR**

- All Radios, Repeaters and Patching systems, Fixed, Portable and Mobile
- Apparatus Tablets, MDTs (Mobile Data Terminals) and WWAN modems
- KnoxBox key retention and drug storage devices and software.
- Operations, Checkoff, and Maintenance of the Mobile Command Platform.
- Operations, Checkoff and Maintenance of the Mobile Tower Platform.
- Tower Sites and Equipment.
- Dashcams and Fleet Telemetric systems.

# Necessary Knowledge, Skills and Abilities

- Must have a working knowledge of LAN topologies and architectures.
- Working knowledge of computer fundamentals, thorough knowledge of computer and peripheral and software operations including word processing, spreadsheets.
- Must be able to demonstrate skill in the use and repair of computer equipment.
- Understand and follow oral and written instructions, explain technical material in layman terms, and develop effective working relationships with co-workers, and administration.
- Understands principles of data communications including ethernet, and installation, and problem determination/resolution.
- Ability to climb communications up to 400 feet.

## TOOLS & EQUIPMENT USED

- Personal computer, including word processing and spreadsheet software; network equipment and software; fax and copy machine,
- Hand and power tools for network and cabling equipment installation.
- Works with rope and pulley systems.
- Harness and lanyards for tower climbs.
